You are about to purchase a product that is not simple and may be difficult to understand.

What is the product?

Type Debt instrument in bearer form, evidenced in the form of uncertificated book-entry securities, governed by Swiss law.

Objectives The objective of this product is to provide you with the possibility to gain exposure to the performance of the Underlying (Global Recovery Stock Selection Basket).

It has a fixed term and will be due on the Maturity Date. You will receive a cash amount on the Maturity Date which corresponds to the sum of the Reference Prices of the Underlying Components on the Valuation Date, each multiplied by the respective number of the component in the basket; such amount in total multiplied by the Ratio.

You will make a loss if such cash amount is below the purchase price of the product.

All payments will be made in the Product Currency.

The product isn't currency hedged at maturity, i.e. all amounts determined in the Currency of the Underlying will be converted into the Product Currency at the relevant exchange rate.

The Underlying is a basket of financial instruments which, subject to corporate actions with regard to basket components, remains unchanged in principle during the term of the product. Components of the basket and their weightings are:

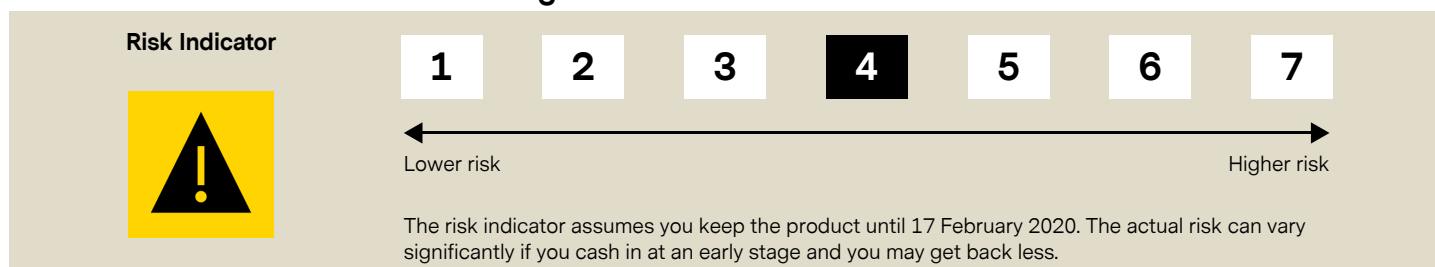

The Issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include the delisting or cessation of an Underlying, changes in legislation, tax events. The investors are able to bear a total loss of their investment and do not attach any importance to capital protection.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Issuer and the Guarantor are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact the capacity of the Issuer and the Guarantor to pay you. **Be aware of currency risk** if your reference currency differs from the Product Currency. **You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies.** This risk is not considered in the indicator shown above. This product does not include any protection from future market performance so you could lose some or all of your investment. If the Issuer and the Guarantor are not able to pay you what is owed, you could lose your entire investment.

Performance Scenarios

What happens if Vontobel Financial Products Ltd. is unable to pay out?

You are exposed to the risk that the Issuer and the Guarantor might be unable to fulfil their obligations in respect of the product and the guarantee – e.g. in the event of insolvency (inability to pay / over-indebtedness) or an administrative order of resolution measures. In case of a crisis of the Guarantor such an order can also be issued by a resolution authority in the run-up of an insolvency proceeding. Thereby the resolution authority has extensive intervention powers. Among other things, it can reduce rights of the investors to zero, terminate the guarantee or convert it into shares of the Guarantor and suspend rights of the investors.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 17 February 2020 (maturity)
