In Switzerland, these financial instruments are considered structured products. ### Product Description

With Put Warrants the investor sets upon decreasing prices of the Underlying. They allow for overproportionate (leveraged) participation in each performance of the Underlying. Accordingly, they can be used for speculation or hedging purposes. These Warrants are exercised automatically on the Expiry Date (european option). If the Relevant Valuation Price is below the Strike Price on the Expiry Date, the investor receives a Repayment Amount after five Bank Business Days. The Repayment Amount corresponds to - taking into account the Ratio - the amount by which the Relevant Valuation Price falls below the Strike Price on the Expiry Date. Otherwise, no payment will be made and the Warrant expires worthless.

## Prospects of Profit and Losses

Put Warrants provide the opportunity to benefit in a leveraged way from a negative performance of the underlying. The maximum potential profit is, however, limited and reached when the price of the underlying drops to zero.

Price changes of the underlying may have an overproportionate impact on the value of the product due to the leverage effect. The settlement amount depends on the amount by which the valuation price of the underlying falls short of the exercise price on the relevant exercise date. Put Warrants do not yield current income. As a rule, they lose value if there is no price loss in the underlying.

At the end of the term, warrants expire worthless if they are not in the money, i.e. in this event the investor incurs a total loss of the capital he has invested.

## Significant Risks for Investors

### Currency risks

If the underlying or underlyings is/are denominated in a currency other than the product's reference currency, investors should bear in mind that this may involve risks due to fluctuating exchange rates and that the risk of loss does not only depend on the performance of the underlying(s) but also on any unfavourable performance of the other currency or currencies. This does not apply for currency-hedged products (quanto structure).

### Market risks

The general market performance of securities is dependent in particular on the development of the capital markets which, for their part, are influenced by the general global economic situation as well as by the economic and political framework conditions in the respective countries (so-called market risk). Changes to market prices such as interest rates, commodity prices or corresponding volatilities may have a negative effect on the valuation of the underlying(s) or the structured product. There is also the risk of market disruptions (such as trading or stock market interruptions or discontinuation of trading) or other unforeseeable occurrences concerning the respective underlyings and/or their stock exchanges or markets taking place during the term or upon maturity of the structured products.
